- Critically assess the ICC's jurisprudence: and its impact on international law.
- Engage in informed discussions on the future of the ICC: and its role in addressing international crimes.

- The Crime of Aggression: Definition, elements, and challenges in its implementation.

Day 3: The ICC's Investigative and Judicial Procedures

- Initiation of Investigations: Referral by States Parties, the Security Council, or proprio motu investigations.
- The Prosecutor's Office: Investigation, evidence gathering, and indictment.
- Judicial Proceedings: Trial procedures, appeals, and reparations.
- The Role of Victims in ICC Proceedings: Participation rights and reparations.

Day 4: Challenges and Criticisms of the ICC

- Complementarity: The relationship between the ICC and national jurisdictions.
- Political Interference and State Cooperation: Challenges to the ICC's independence and effectiveness.
- Criticisms of the ICC: Concerns regarding selectivity, bias, and impact.

Day 5: The Future of the ICC

- Emerging Challenges: Addressing impunity for mass atrocities, cybercrime, and terrorism.
- Strengthening the ICC: Enhancing cooperation, addressing resource constraints, and improving efficiency.
- The Role of the ICC in International Justice: The future of international criminal justice and the ICC's place within it.
