  - Copyright Limitations: Public domain, compulsory licenses, limitations for libraries and archives
- Afternoon:
  - Digital Rights Management (DRM): Technologies for protecting copyrighted works, DRM controversies

## Day 3: Copyright in the Digital Environment

- Morning:
  - Copyright on the Internet: Copyright issues related to websites, social media, and online platforms
  - Online Piracy: Copyright infringement on the internet, file sharing, and illegal streaming
  - Digital Millennium Copyright Act (DMCA): Safe harbour provisions, takedown notices
- Afternoon:
  - Copyright and Artificial Intelligence: AI-generated content, copyright ownership of AI-created works

  - Ethical Considerations in Copyright: Balancing the rights of creators with the public interest

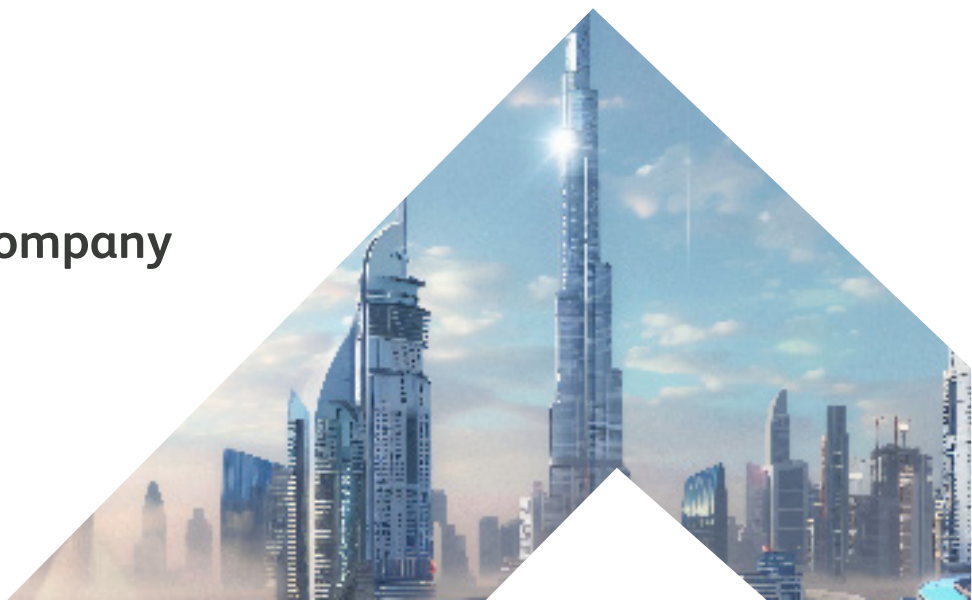
